Re: **Louisiana Do Not Call Program**  
**Principal Solicitor Registration Renewal 2025**

Dear Sir or Madam:

The Louisiana Public Service Commission Do Not Call program accepts telephonic solicitor registrations based on the calendar year, January through December. The last quarter LPSC Do Not Call registry for calendar year 2024 was issued from our office September 13, 2024. The first quarter LPSC Do Not Call registry for calendar year 2025 will be issued from our office on or about December 15, 2024, and will be effective for enforcement on January 1, 2025.

Our records show your business was a registered **Principal telephonic solicitor** with our program in 2024. To continue your participation with the LPSC Do Not Call program without a break in registration, please submit your re-registration packet on or before December 8, 2024. Your packet must contain a completed Principal telephonic solicitor renewal application (copy enclosed for your convenience), and certified funds for the applicable amount (Principal and Dependent registration and list fees) made payable to the Louisiana Public Service Commission, and an electronic spreadsheet containing consolidated Dependent data if applicable. If your company registers twenty or more Dependent solicitors, an electronic version of the dependent registration details must be submitted. The format required for this data collection is available on the solicitor's page of our website at [https://lpsc.louisiana.gov/DNC\\_SolicitorAppInfo](https://lpsc.louisiana.gov/DNC_SolicitorAppInfo).

There have been no changes to the registration fee schedule for the 2024 calendar year. Although we do not accept company checks, wire transfer and credit card options are available, as well as certified checks and money orders. Information regarding the payment process can be found on our website at [https://lpsc.louisiana.gov/DNC\\_SolicitorAppInfo](https://lpsc.louisiana.gov/DNC_SolicitorAppInfo).

A Dependent registration renewal form has also been included in your registration packet. You are instructed to provide a copy of this form to any Dependent solicitor that you will authorize with your registration. These Dependent solicitors **MUST** complete their portion of the application **and forward it to you for your approval**. *The approval consists of completing the applicable Principal solicitor information, attaching the applicable Dependent registration fees, and having your Designated Contact person complete the Acknowledgement and Approval of Principal solicitor section (this MUST BE SIGNED AND NOTARIZED in TWO PLACES ON THE DEPENDENT FORM).* Please submit the complete Dependent forms along with your Principal registration packet if possible. You may not disseminate registry information to a Dependent solicitor until they are properly registered and authorized by our office. Our office has **NOT** mailed individual packets to your dependents, but all registration forms are available on our website for download.

We appreciate your participation in the LPSC Do Not Call program. I would like to remind you that even though you might subscribe to the National Do Not Call List, you must also subscribe at the state level, to make phone calls into our state. If your company has decided not to reregister at this time, I remind you that all solicitation calls must be made in compliance with both state and federal DNC programs.
