# LOUISIANA PUBLIC SERVICE COMMISSION MINUTES FROM OCTOBER 19, 2022 OPEN SESSION

MINUTES OF OCTOBER 19, 2022 OPEN SESSION OF THE LOUISIANA PUBLIC SERVICE COMMISSION HELD IN BATON ROUGE, LOUISIANA. PRESENT WERE CHAIRMAN LAMBERT BOISSIERE, VICE CHAIRMAN MIKE FRANCIS, COMMISSIONER FOSTER CAMPBELL, COMMISSIONER ERIC SKRMETTA, COMMISSIONER CRAIG GREENE, AND EXECUTIVE SECRETARY BRANDON FREY.

Open Session of October 19, 2022, convening at 9:47 a.m., and adjourning at 12:36 p.m., the Galvez Building, 602 North 5<sup>th</sup> Street, Baton Rouge, Louisiana, with the above-named members of the Commission and Executive Secretary Brandon Frey present.

Ex. 1 Chairman Boissiere acknowledged and welcomed former Executive Secretary, Eve Gonzalez to the meeting. He also discussed the devastation in Florida due to Hurricane Ian and requested thoughts and prayers for those impacted.

Commissioner Greene acknowledged and recognized the board members of JDEC and DEMCO that were present at the meeting, as well as SLECA's General Manager/CEO Joe Ticheli.

Commissioner Skrmetta announced that the November B&E Session will be on Thursday, November 17, 2022 at the Copeland Towers in Metairie. He also welcomed former Commissioner, Jay Blossman, to the meeting.

Mark Kleehammer, Vice President of Regulatory and Public Affairs for Entergy, provided information on the current state of natural gas prices and their impacts on Entergy's electric rates.

Deputy General Counsel Lauren Evans announced the Public Utilities CLE will be held Friday, December 2, 2022 at City Club in Baton Rouge with registration details forthcoming. Mrs. Evans also announced the Louisiana Chapter of the Energy Bar Association will host a networking event in conjunction with NARUC on Sunday, November 13, 2022 from 5:00 p.m. – 7:00 p.m. at Phelps Dunbar located at 365 Canal Street, Suite 2000 in New Orleans.

Executive Secretary Brandon Frey asked for prayers for the family of Pam Meades, a former LPSC employee who recently passed way.

- Discussion and possible vote to ratify interventions of the Commission in RTO or ERSC related FERC proceedings.

On motion of Commissioner Skrmetta, seconded by Commissioner Greene, and unanimously adopted, the Commission voted to ratify the Louisiana Public Service Commission's intervention filed in FERC proceedings ER22-2763, ER22-2814, ER22-2891 and RM21-11.

#### 5) Directives

- Directive to jurisdictional electric utilities regarding utility poles.

## At the request of Commissioner Skrmetta.

In reviewing the initial reports regarding the damage and restoration efforts in Florida following the impacts of Hurricane Ian, there appears to preliminary evidence that the use of certain pole types in the respective utility's high-risk service areas may have resulted in less damage and destruction, and thus quicker restoration/outage times. Specifically, those distribution and transmission poles, that were concrete in composition, appear to have fared positively. Given the potential impact storms have on Louisiana utilities, I believe the potential benefits of such construction should be properly analyzed in Louisiana, and therefore direct Staff to open a docket, or make a recommendation in any applicable existing docket, requiring all jurisdictional electric utilities to each implement a pilot program wherein a certain number of distribution and/or transmission poles, determined by the Staff, are replaced within the next twelve months of this date with those using concrete construction. After placement and analysis, each electric utility shall annually report back to the Commission with a comprehensive review on performance and resilience.

After discussion, with opposition by Commissioner Greene, Commissioner Campbell, Vice Chairman Francis, and with Chairman Boissiere abstaining, the Directive failed.

Chairman Boissiere directed Staff to open a docket to review the Commission's current Consumer's Bill of Rights found in General Order dated November 6, 1997 (the Fuel Adjustment Clause General Order) to broaden the Consumer's Bill of Rights outside of fuel costs and adjustments. Further, the Chairman requested Staff to open a dialogue with the State of Florida and the Florida Public Service Commission regarding recovery efforts and lessons learned from addressing storms and disasters, including the recent Hurricane Ian.

On motion of Commissioner Skrmetta, seconded by Vice Chairman Francis, with Chairman Boissiere and Commissioner Greene concurring, and Commissioner Campbell absent, the Commission voted to adjourn.
